EARLY EXERCISE OF OPTIONS BY DIRECTORS

APPENDIX 2A AND CLEANSING NOTICE

Black Cat Syndicate Limited ("Black Cat" or "the Company") is pleased to announce that a total of 1,150,000 ordinary fully paid shares have been issued on the early exercise of options by directors. The options were exercisable at any time until 25 January 2023 at an exercise price of \$0.20 per option.

The exercise of the options follows the announcement that Black Cat has entered into a binding acquisition terms sheet ("Acquisition") to acquire the Fingals and Rowe's Find Gold Projects from Silver Lake Resources Limited ("Silver Lake" (ASX:SLR)), subject to the satisfaction of certain conditions (refer ASX announcement 28 May 2020).

The amount raised on the exercise of the options by directors amounts to \$230,000 and adds to Black Cat's already strong cash position (\$3.7M at 31 March 2020). This brings the total amount invested by directors in Black Cat to over \$1.4M. The shares issued will be subject to a voluntary escrow until 30 January 2021.

Black Cat's Chairman, Paul Chapman, said: "Black Cat is thrilled with the Acquisition of the Fingals and Rowe's Find Gold Projects. Furthermore, Black Cat's directors have demonstrated their support for the Acquisition by an early exercise of options and placement of the resulting shares into voluntary escrow. We are extremely positive about Black Cat's prospects going forward."
